"New plumbing laws and water demand management" information training sessions

Purpose

The purpose of this Newsflash is to advise of upcoming dates for industry training on the new plumbing laws and water demand management measures.

Background

South-east Queensland is experiencing the effects of the worst drought on record. Changes have been introduced through amendments to the *Plumbing and Drainage Act 2002*, the Queensland Plumbing and Wastewater Code and the Queensland Development Code aimed at preserving our valuable drinking water supplies.

Training sessions

Training sessions to be conducted by Building Codes Queensland have been arranged to provide an overview of the following:

- Expanded allowable uses of treated greywater;
- Sub-metering of new multi-unit residential and non-residential premises;
- Queensland Plumbing and Wastewater Code
- Changes to the Queensland Development code for retrofitting of water efficient devices at time of major renovation;
- Allowing treated greywater to be used to meet water saving targets for class 1 buildings (houses and townhouses); and
- Introduction of a new part of the Queensland Development Code MP 4.3 Alternative Water Sources - Commercial Buildings, requiring all new commercial buildings to have alternative water sources




