Seminars on new disability access standards for buildings

Purpose

To advise stakeholders of the upcoming seminars on the new disability access standards for buildings.

Background

The new Commonwealth Disability (Access to Premises – Buildings) Standards (Premises Standards) will come into force on 1 May 2011. They are expected to deliver significant improvements in the level of access for new buildings and existing buildings undergoing renovation. Corresponding changes are proposed to the Building Code of Australia to commence at the same time.

Half day Brisbane seminars will be held in August 2010 to provide designers, architects, builders, building owners, managers, building certifiers, access consultants, advocates and other interested stakeholders with an overview of the Premises Standards and their effect. The seminars will also provide an opportunity for participants to discuss questions of interpretation.

The seminars will cover:

- the objectives behind the Premises Standards
- who is responsible for complying with the Premises Standards
- the main features of the Premises Standards, including exceptions and concessions
- areas of buildings and levels of access required.

The seminars will be presented by the Australian Human Rights Commission and the Australian Building Codes Board, both of which have been closely involved in the development of the Premises Standards for a number of years.

Seminars will be held in Brisbane on **Thursday 12** and **Friday 13 August 2010** from 9:30 am to 1 pm at rooms P1 and P2, Brisbane Convention and Exhibition Centre, Merivale Street, South Brisbane. Registration will commence at 8:45 am.
