



# AIRAH INFORMATION WORKSHOPS ON SECTION J (VOLUME ONE)



Part of the Australian Government's policy for greenhouse gas emission reduction includes significant improved energy efficiency in buildings. From May this year the Building Code of Australia (Volume One) drastically improves energy efficiency measures in Section J.

According to supporting commentary on the proposals to amend the energy efficiency provisions in the BCA (Vol 1) for 2010 the following provisions were laid out:

- Offices – between 14 and 22% energy reduction
- Department stores – between 22 and 27% energy reduction
- Schools / Universities – between 18 and 31% energy reduction
- Hospitals – between 14 and 40% energy reduction
- Office buildings heating plant improvements up to 12%, cooling plant up to 26%, fans and pumps a massive 52%

**Presenter: Doug Elms L.AIRAH**, one of Australia's pre-eminent energy specialists, will take you through the application of *Part J5 – Air Conditioning and Ventilation and J8 Access for Maintenance and Facilities for Monitoring*. Doug takes the technical detail in the BCA and delivers it in an easy to understand and apply way – his seminar series in 2008 generated tremendous feedback from both mechanical services professionals, architects and buildings surveyors.
